**TENDER NOTICE FOR THE SUPPLY OF COUNTRY LIQUOR (2018-19)**

1. The Department of Excise is going in for e-tendering for procurement of Country Liquor in the NCT of Delhi. Tenders in the prescribed form, are invited from working distilleries or bottling plants duly licensed by the Central or a State Government for the grant of three or more licenses in Form L-3 under Rule 48 of the Delhi Excise Rules, 2010 for the wholesale supply of country liquor of 50 degree under proof (U.P) for retail vends (L-8) in bottles of 750 ml., 375 ml. and 180 ml. in the **ratio of 4:4:2 during the period from 1<sup>st</sup> April 2018 to 31<sup>st</sup> March, 2019.** The holder of an L-3 license shall also be required to obtain a license in form L-33 for the bonded warehouse.
2. The tenders, duly completed in all respects and accompanied by the following documents, should be scanned and uploaded in the website upto **11:00 AM on 23/02/2018.**
  - a. Demand draft or pay order issued by Nationalized Bank for Rs.30,00,000/- (Rupees thirty lakhs only) drawn in favour of the Excise Commissioner, Delhi as earnest money, alongwith receipt of physically depositing the same as per point No.3 below.
  - b. 'No Dues Certificate' in favour of the tenderer issued by the Dy. Commissioner (Excise), Delhi after the date of this notice.
  - c. An affidavit declaring that the information given in the tender form is true and correct and that no fact has been concealed there from.
  - d. True attested copy of valid distillery license or bottling plant licence issued by the Competent Authority.
  - e. Document showing permitted installed capacity for the manufacture of country liquor. The installed capacity should be minimum two times the quantity of country liquor proposed in the tender documents by the tenderer.
  - f. Statement indicating the actual production and supply of country liquor during the last 5 years, duly authenticated by the concerned Excise Commissioner of the State in which the distillery/bottling plant is situated.

- g. "No Dues and Credibility" certificate regarding past performance of production and supply from the Excise Commissioner of the State in which the distillery/bottling unit is situated.
  - h. Consent of the Excise Commissioner of the State where distillery/ bottling plant is situated for supply of country liquor from that State to the National Capital Territory of Delhi in which the capacity of the distillery / bottling plant should be clearly mentioned.
  - i. A statement indicating the maximum quantity of country liquor that can be supplied to Delhi by the tenderer from each of its units.
  - j. No dues Certificate from the Trade & Tax Department of NCT of Delhi.
  - k. An affidavit declaring no violation of Clause 7 of the terms & conditions for the year 2018-19 for the supply of country liquor.
  - l. Copy of PAN Card
3. Demand draft/pay order issued by a nationalized bank as earnest money of Rs.30,00,000/- (Rupees Thirty lakhs only) is to be physically deposited with the Accounts Officer in the Office of Commissioner (Excise), Delhi. Other documents are to be scanned and uploaded alongwith the tender form.
  4. The tender will be opened at 12.00 noon on 23 / 02 /2018 in the Room of Excise Commissioner, L-Block, Vikas Bhawan, I.P. Estate, New Delhi-110 002 in the presence of the tenderers or their authorized representatives who wish to be present.
  5. Conditional offers, offers without bank draft or earnest money, other documents etc. and offers, which are not in the prescribed tender form/documents, will not be entertained and will be summarily rejected. Tenders received after the stipulated date and time will not be entertained and shall be rejected.
  6. Commissioner of Excise reserves the right to accept or reject any or the tenders without assigning any reason thereof.
